That the school timings vacations and mid-term holidays shall be followed as prescribed by Government from time to time

That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.

That the results of institution shall be satisfactory every year

That the records/ accounts shall be furnished to the District Educational Officer, every year by 30th September at least.

That the list of Governing Body shall be furnished to the District Educational Officer, every year.
